- Follow all barn safety rules and staff instructions.
- Immediately report any injury or health concern involving the Horse.

6. Liability and Risk

Lessee understands that horseback riding is inherently risky. Lessee agrees to assume all risks of injury or damage resulting from participation in this lease.

Lessee (and parent/guardian if under 18) agrees to hold harmless and indemnify the Barn/Owner, instructors, and employees from all liability for injury, death, or property damage arising from this Agreement.

Lessee must sign a separate **Liability Waiver** before participating.

7. Termination
Either party may terminate this Agreement with 30 days' written notice . Barn/Owner reserves the right to terminate immediately if Lessee violates barn rules, mistreats the Horse, or engages in unsafe behavior.
8. No Subleasing or Off-Property Use
Lessee may not sublease, loan, or remove the Horse from the premises for any reason without written permission from Barn/Owner. Attending horse shows with Barn/Owner is allowed.
9. Entire Agreement
This Agreement represents the entire understanding between the parties and supersedes any prior agreements, whether written or verbal. Any changes must be made in writing and signed by both parties.
10. Governing Law
This Agreement shall be governed by and interpreted in accordance with the laws of the State of
